ANSWERS TO QUESTIONS RECEIVED THROUGH 11:00 A.M. ON MAY 5, 2020:

Q#1 Will the additional alternative studies for raising the bridges to 15'-6" and 16'-6" apply to the MP 27.3 structure that has a newer deck slab already in place or only to those structures that will be re-decked with the project.

A#1 The investigation to raise the bridge at MP 27.3 to increase vertical clearance shall be considered in the Proposal.

Q#2 If available, can you please provide the latest load rating reports and inspection findings for the four structures. We understand that MP 32.2 and 46.4 have just been load rated last year (2019). Also, it appears that the fascia beam on the east side of the MP 37.1 structure has truck impact damage that has been repaired with flange splice plates. Please provide any information that you may have on file for this repair.

A#2 The load ratings reports and latest inspection reports for the four bridges are available by sending a request to purchasing@ohioturnpike.org. The Commission does not have the repair details for the apparent fascia beam damage on the east side of the MP 37.1 structure.
