ANSWERS TO QUESTIONS RECEIVED THROUGH 2:00 P.M. ON MARCH 1, 2022:

Q#1 Thanks for expediting the plans. Can you also provide the inspection reports for the bridges on LOI 3 & 4?

A#1 There are no inspection reports available for the bridges in LOI 3 and 4. Condition reporting from the most recent annual inspections of the structures is available in ODOT's TIMS system.

Q#2 Please clarify if the organizational chart and additional resumes must be kept to a two-page limit. Given that the total length of the proposal is 12 pages, it would be very helpful not to limit the org chart and resume section to two-pages. Please consider removing the limit on organizational chart and resumes.

A#2 The resumes must be kept to a two page limit. The organizational chart is not included in this limit.

Q#3 Can you please confirm that ODOT prequalification is required for protective coating inspection for this design project?

A#3 ODOT prequalification for protective coating inspection is not required for this project.

Q#4 Also, for the LOI 4-2022 project, does OTIC want the steel beam coating system replaced?

A#4 The protective coating system is not to be replaced on this project.

Q#5 Is it acceptable to bring on sub-disciplines not explicitly listed in the RFP, e.g., geotechnical, environmental, etc. if the consultant sees value to the project(s)?

A#5 It is acceptable to add sub-disciplines to the consultant's proposal where appropriate.

Q#6 The RFP states: "Provide references from three organizations other than the Ohio Turnpike and Infrastructure Commission for similar projects and services completed in the past three years. Is it acceptable to provide references from three different ODOT districts as "three organizations other than OTIC?"

A#6 It is acceptable to provide references from three different ODOT districts although this will not be viewed as being as complete as providing references from three distinct organizations.
