The Work to be performed under the Contract for Project No. 43-25-03 consists of replacement of bridge decks, raising of superstructure, superstructure replacement, replacement of approach slabs, abutment slabs, deck joints, bearings; sealing of constructions joints; patching and repair of substructure; concrete weatherproofing; maintenance of traffic; and all other items incidental to the completion of work. All Work is to be performed as per the Plans, Drawings, Specifications, Special Provisions, Technical Specifications, and other Contract Documents for this Project.

Bids will be accepted until **February 4, 2025, at 2:00 P.M. (Eastern Time)**, when all Bids will be accessed, opened and read aloud. Bidders should submit all questions no later than seven (7) days prior to Bid Opening.
