Bids will be received for this Project, which includes the following:

Installation of overhead dynamic message signs and variable speed limit signs and their associated appurtenances such as overhead gantries, CCTV cameras, and RWIS systems at various locations throughout the Ohio Turnpike. All Work is to be performed as per the Plans, Drawings, Specifications, Special Provisions, Technical Specifications, and other Contract Documents for this Project.

Bids will be accepted until **April 30, 2026, at 2:00 P.M. (Eastern Time)**, when all Bids will be accessed, opened and read aloud. Bidders should submit all questions no later than seven (7) days prior to Bid Opening.
