Bids will be received for this Project, which includes the following:

The demolition of the existing Erie Islands Service Plaza Wastewater Treatment Plant, installation of new truck parking, drainage, maintenance of traffic, pavement marking, signage, lighting, landscaping, and other related items and includes the furnishing of all materials, labor, equipment, tools and services. All Work is to be performed as per the Plans, Drawings, Specifications, Special Provisions, Technical Specifications, and other Contract Documents for this Project.

Bids will be accepted until **June 26, 2025, at 2:00 P.M. (Eastern Time)**, when all Bids will be accessed, opened and read aloud. Bidders should submit all questions no later than seven (7) days prior to Bid Opening.
