Bids will be received for this Project, which includes the following:

The project will include the required site civil, electrical and structural work for the new Toll Collection System (TCS) integration. Work shall include but not limited to the following: removal/demolition of treadles and scale pits, pavement replacement, saw cutting of loops, modifications of toll booths, installation of supports for cameras and cabinets, installation of conduit, pull/curb boxes, wire and appurtenances to install needed infrastructure, temporary traffic control and all other items noted on the drawings at multiple Toll Plazas. All Work is to be performed as per the Plans, Drawings, Specifications, Special Provisions, Technical Specifications, and other Contract Documents for this Project.

Bids will be accepted until **October 26, 2021, at 2:00 P.M. (Eastern Time)**, when all Bids will be accessed, opened and read aloud. Bidders should submit all questions no later than seven (7) days prior to Bid Opening.
