The Work includes, but is not limited to, excavating existing pavement, chemically stabilizing the subgrade, construct full depth pavement, performing drainage repairs and replacements, tree removal, right of way fence replacement, installing concrete barrier wall, asphalt curbs, guardrail, pavement markings and other traffic control devices, performing temporary traffic control and minor lighting work. All Work is to be performed as per the Plans, Drawings, Specifications, Special Provisions, Technical Specifications, and other Contract Documents for this Project.
