Bids will be received for this Project, which includes the following:

Rehabilitation of Structure or Replacement of bridge decks, bridge deck joints, bearings; sealing of constructions joints; performing concrete weatherproofing; maintenance of traffic; and all other items incidental to the completion of work. All Work is to be performed as per the Plans, Drawings, Specifications, Special Provisions, Technical Specifications, and other Contract Documents for this Project.

Bids will be accepted until **January 18, 2023, at 2:00 P.M. (Eastern Time)**, when all Bids will be accessed, opened and read aloud. Bidders should submit all questions no later than seven (7) days prior to Bid Opening.

Contract Documents are available by registering for a free vendor account and logging into Bid Express® (<https://www.bidexpress.com>). However, Bidders must obtain a paid subscription to Bid Express and select the Project for Bidding to submit a Bid.
