Failure to certify a commitment to meet the SBE Goal or failure to satisfactorily demonstrate Good Faith Efforts used to attain SBE participation for this project shall be grounds for the Commission to consider the Bid nonresponsive and may cause the Bid to be rejected.

Pollution Liability Insurance is required under GC Art. 12.1.3 for this Project.

Bids will be received for this Project, which includes the following:

The Work to be performed under the Contract for Project No. 43-25-04 consists of raising bridges to improve vertical clearance, including embankment, excavation, and minor roadway work; replacement of bridge decks, approach slabs, abutment slabs, deck joints, bearings; sealing of constructions joints; patching and repair of substructure; concrete weatherproofing; maintenance of traffic; and all other items incidental to the completion of work. All Work is to be performed as per the Plans, Drawings, Specifications, Special Provisions, Technical Specifications, and other Contract Documents for this Project.

Bids will be accepted until **October 23, 2024, at 2:00 P.M. (Eastern Time)**, when all Bids will be accessed, opened and read aloud. Bidders should submit all questions no later than seven (7) days prior to Bid Opening.

Contract Documents are available by registering for a free vendor account and logging into Bid Express® (<https://www.bidexpress.com>). However, Bidders must obtain a paid subscription to Bid Express and select the Project for Bidding to submit a Bid.
