Bids will be received for this Project, which includes the following:

The Work to be performed under the Contract for Project No. 43-25-06 RE-BID consists of widening of M.P. 180.3 and M.P. 182.1 structures, raising bridges to improve vertical clearance, including embankment, excavation, foundations, and minor roadway work; replacement of bridge decks for all 3 structures, parapets, approach slabs, abutment slabs, deck joints, bearings; sealing of constructions joints; drainage adjustment; patching and repair of substructure; concrete weatherproofing; maintenance of traffic; and all other items incidental to the completion of work. All Work is to be performed as per the Plans, Drawings, Specifications, Special Provisions, Technical Specifications, and other Contract Documents for this Project.

Bids will be accepted until **August 5, 2025, at 2:00 P.M. (Eastern Time)**, when all Bids will be accessed, opened and read aloud. Bidders should submit all questions no later than seven (7) days prior to Bid Opening.
