Prevailing Wage Rates and Equal Employment Opportunity requirements apply to this Project.

The Small Business Enterprise (SBE) Goal applicable to this Project is 5%.

Failure to certify a commitment to meet the SBE Goal or failure to satisfactorily demonstrate Good Faith Efforts used to attain SBE participation for this project shall be grounds for the Commission to consider the Bid nonresponsive and may cause the Bid to be rejected.

Pollution Liability Insurance is required under GC Art. 11.1.3 for this Project.

Bids will be received for this Project, which includes the following:

Rehabilitation of bridges decks at mileposts 163.8, 193.1, and 215.4 by use of hydro-demolition and micro-silica modified concrete overlay. Rehabilitation of bridge at milepost 228.6 by concrete patching and fiberwrapping of existing pier columns. Crack repair injection, concrete weatherproofing, maintenance of traffic, and all other items incidental to the completion of the Work. All Work is to be performed as per the Plans, Drawings, Specifications, Special Provisions, Technical Specifications, and other Contract Documents for this Project.

Bids will be accepted until **July 9, 2026, at 2:00 P.M. (Eastern Time)**, when all Bids will be accessed, opened and read aloud. Bidders should submit all questions no later than seven (7) days prior to Bid Opening.

Contract Documents are available by registering for a free vendor account and logging into Bid Express® (<https://www.bidexpress.com>). However, Bidders must obtain a paid subscription to Bid Express and select the Project for Bidding to submit a Bid.

The Contract Documents may be reviewed for bidding purposes without charge by registering and logging into Bid Express®.
