Project No. 99-22-04 (Part A) consists of the following:

Repair of damaged structural steel members, including heat straightening of a beam segment, connection plates, and diaphragms; maintenance of traffic; and all other items incidental to the completion of the Work.

Project No. 99-22-04 (Part B) consists of the following:

Replacement of a beam segment, jacking the superstructure, removing and replacing portion of the deck and barrier; maintenance of traffic; and all other items incidental to the completion of the Work.

All Work is to be performed as per the Plans, Drawings, Specifications, Special Provisions, Technical Specifications, and other Contract Documents for this Project.

Bids will be accepted until **June 2, 2023, at 2:00 P.M. (Eastern Time)**, when all Bids will be accessed, opened and read aloud. Bidders should submit all questions no later than seven (7) days prior to Bid Opening.
