Bids are to be submitted in accordance with the Contract Documents prepared by the Commission.

Prevailing Wage Rates and Equal Employment Opportunity requirements apply to this Project.

The Small Business Enterprise (DBE/EDGE/SBE) Goal applicable to this Project is 15%.

Pollution Liability Insurance is required under GC Art. 12.1.4 for this Project. Builder’s Risk Insurance is required under GC Art. 12.2.1 for this Project.

Bids will be received for Project No. 58-20-01, which includes the following:

The work to be performed under this Contract consists of the complete construction of a new Mainline Toll Plaza Facility, Toll Plaza 49, in Lucas County, Ohio. The local address of the North Toll Plaza Site is 2400 Scott Road, Swanton Ohio 43558, and the local address of the South Toll Plaza Site is 14105 Shaffer Road, Swanton Ohio 43558.

The Work includes, but is not limited to, the miscellaneous site improvements and utilities; new construction of two utility buildings, toll islands and booths, two canopies, prefabricated steel truss pedestrian bridge, concrete pavement and curbing, earthwork, storm drainage, water line work, sanitary sewer work, grading, seeding, SWPPP management, underground electric and communication lines, overhead gantries and sign structures, temporary traffic control, building standby electric generator, plumbing, heating, ventilation system, air conditioning, electrical, communication, and other work incidental to these major items as shown on the drawings and/or specified in the Specifications and these Special Provisions.

The Project will be performed under a Single Prime Contract. The bid shall be made on the Ohio Turnpike and Infrastructure Commission (the Owner or the Commission) provided Bid Form which includes individual and lump sum bid items. Prime Contractor, subcontractors, material suppliers and manufacturers shall base their bids and work on “year around construction” for this project and

are to comply with the established Completion Schedule accordingly (regardless of weather). All Bidders are required to review the drawings, Specifications, Special Provisions and the Summary of Work to ascertain a complete understanding of the scope. All Work is to be performed as per the Plans, Drawings, Specifications, Special Provisions, Technical Specifications, and other Contract Documents for Project No. 58-20-01.

Bids will be accepted until **May 21, 2020, at 2:00 P.M. (Eastern Time)**, when all Bids will be accessed, opened and read aloud. Bidders should submit all questions no later than seven (7) days prior to Bid Opening.
