#### Part A:

Removal by milling of two (2) inches of existing asphalt pavement in the center and right lanes of the mainline for Plan specified limits, removal by milling of five (5) inches of existing asphalt pavement in the right lane for Plan specified limits, resurfacing of the pavement to the thickness specified in the Drawings, various full depth pavement repairs, installation of raised pavement markers and permanent pavement striping and/or other pavement markings, and temporary traffic control, in both Eastbound and Westbound lanes and all other items incidental to the completion of the Work.

### Part B:

Removal by milling of three (3) inches of existing asphalt pavement on the interchange pavement and shoulders, resurfacing of the interchange pavement and shoulders to the thickness specified in the Drawings, full depth concrete pavement repairs of portions of interchange ramp pavement, installation of raised pavement markers and permanent pavement striping and/or other pavement

markings, upgrading of guardrail, temporary traffic and all other items incidental to the completion of the Work.

All Work is to be performed as per the Plans, Drawings, Specifications, Special Provisions, Technical Specifications, and other Contract Documents for Project No. 59-20-04.
