

OHIO TURNPIKE COMMISSION

Resolution No. 149 - 1953 Finding it Necessary to Change the Location of Certain
State Highways

WHEREAS Portions of certain state highways intersect the route to be traversed by Ohio Turnpike Project No. 1, hereinafter called "the turnpike", and

WHEREAS §1206 of the Ohio General Code provides for the relocation of any portion of any state highway upon the Commission's finding that it is necessary to change the location thereof;

NOW, THEREFORE, BE IT

RESOLVED that the Commission, having duly and fully considered the same, finds it necessary to change the location of the following-designated portions, respectively, of each of the following-designated state highways:

1. That portion of State Route 626, Beaver Township, Mahoning County, Ohio, the centerline of which presently intersects the centerline of the turnpike at or near turnpike station 903+94.69 and which extends from a point at or near state highway station 58+00 on existing State Route 626 in a northerly direction along the center line of said existing state route approximately 1080 feet to a point at or near state highway station 47+20.
2. That portion of State Route 303, Braceville Township, Trumbull County, Ohio, the centerline of which presently intersects the centerline of the turnpike at or near turnpike station 67+05.66 and which extends from a point at or near state highway station 28+62 in an easterly direction approximately 1850 feet to a point at which State Route 303 intersects State Route 82.
3. That portion of State Route 3, Royalton Township, Cuyahoga County, Ohio, the centerline of which presently intersects the centerline of the turnpike at or near turnpike station 708+53.73 and which extends from a point at or near state highway station 4+66 in a southwesterly direction along the centerline of existing State Route 3 approximately 1500 feet to a point at or near highway station 10+33.
4. That portion of State Route 105, Harris Township, Ottawa County, Ohio, the centerline of which presently intersects the centerline of the turnpike at or near turnpike station 218+00 and which extends from a point at or near state highway station 8+38 west of the intersection of the turnpike with State Route 105 in an easterly direction 1530 feet more or less to a point at or near highway station 8+25 east of the intersection of the turnpike with State Route 105.
5. That portion of State Route 163, Lake Township, Wood County, Ohio, the centerline of which presently intersects the centerline of the turnpike at or near turnpike station 539+31.71 and which extends from a point at or near highway station 4+13 in an easterly direction along the centerline of existing State Route 163 approximately 2750 feet to a point at or near state highway station 33+26.

6. That portion of State Route 15, Jefferson Township, Williams County, Ohio, the centerline of which presently intersects the centerline of the turnpike at or near turnpike station 701+67.58 and which extends from a point at or near state highway station 5+00 in a northerly direction along the centerline of existing State Route 15 approximately 2800 feet to a point at or near highway station 40+02.
7. That portion of State Route 631, Hudson Township, Summit County, Ohio, the centerline of which presently intersects the centerline of the turnpike at or near turnpike station 576+94.17 and which extends from a point at or near state highway station 3+52 in a southeasterly direction along the centerline of existing State Route 631 approximately 2700 feet to a point at or near the intersection of said State Route 631 with State Route 91.

FURTHER RESOLVED that the Secretary of the Commission be and he hereby is authorized and instructed to transmit a certified copy of this resolution to the Director of Highways of the State of Ohio.
