

OHIO TURNPIKE COMMISSION

Resolution No. 7/-1953 Awarding Construction Contract C-38

WHEREAS the Commission has duly advertised according to law for bids upon a contract for the construction of a portion of Ohio Turnpike Project No. 1 which has been designated as Construction Section C-38 and consists of twin bridges over the Sandusky River, and proof of said advertising is before the Commission;

WHEREAS the Commission has advertised in like manner for bids upon separate contracts for the construction of each of two portions of said construction section, which portions are designated C-38-A and C-38-B, and consist of the substructure and superstructures, respectively, for said twin bridges, and proof of said advertising is likewise before the Commission;

WHEREAS bids for the performance of each and all of said contracts have been received and were duly opened and read as provided in the published notice for said bids, and said bids are before this meeting:

WHEREAS said bids have been analyzed by the Commission's consulting engineer and by its chief engineer, and they have reported thereon to the Commission with respect to said analysis and made their recommendations predicated thereon;

WHEREAS all of the aforesaid bids for each of said contracts were solicited on the basis of the same terms and conditions and the same specifications, with respect to all bidders and potential bidders, and the bid of George Vang, Inc., for the performance of Contract C-38 was, and is by the Commission determined to be, the lowest of all said bids, or combinations of bids, for the construction of said Construction Section; and the Commission has been advised by its general counsel that said bid conforms to the requirements of Section 1205 of the General Code of Ohio, and of the terms and conditions and specifications and legal notice applicable thereto, and, accordingly, the Commission is authorized to accept said bid as the lowest and best bid;

WHEREAS the Commission is satisfied with the capacity of said bidder to perform its obligations pursuant to its proposal;

NOW, THEREFORE, BE IT

RESOLVED that the bid of George Vang, Inc. for the performance of Construction Contract C-38, Ohio Turnpike Project No. 1, be, and hereby it is, determined to be the lowest and best of all bids or combinations of bids, and is accepted;

Copies hereof furnished 4/1/53 to chief engineer, consulting engineer (2), Continue attack attorney, and chairman.

and that each of the chairman and the chief engineer be, and each of them hereby is, authorized (1) to execute a contract with said successful bidder in the form heretofore prescribed by the Commission, pursuant to the aforesaid bid and upon condition that said successful bidder shall furnish a performance bond as heretofore approved by the Commission by and in its Resolution No. 60-1952, and meeting the requirements of said resolution, (2) to return to all other bidders for said Contracts C-38, C-38-A, and C-38-B, the bid security furnished by each of them, respectively, (3) to return said successful bidder's bid security when the aforesaid contract shall have been duly executed and said performance bond furnished, and (4) to take any and all action necessary or proper to carry out the terms of said bid and of said contract.
