OHIO TURNPIKE COMMISSION

Resolution Awarding Contracts for Construction of Portage Service Plaza under Contract No. 53-99-01 and Brady's Leap Service Plaza under Contract No. 53-99-02

WHEREAS, the Commission has duly advertised according to law for bids upon contracts for the construction of a *new* Ohio Turnpike Service Plaza and service facilities at the premises commonly known as **Portage** Service Plaza and **Brady's Leap** Service Plaza located at Milepost 197.0 in Portage County, said contracts included bid packages that essentially would demolish the existing service plaza (one-story structure with basements) fuel canopies, fuel islands and other site amenities and replace them and all the other service facilities, structures, parking areas and ramps with new construction, which projects have been identified as **Project No. 53-99-01 and 53-99-02**;

WHEREAS, pursuant to Resolution No. 58-1997, the Commission authorized its executive director and general counsel to take any and all action necessary to advertise for bids for the renovation or replacement, construction of any or all of the Commission's service plaza facilities, which resolution provided that no more than two (2) pairs will be under construction during a one-year period, and that the service plaza facility will be closed while it is under reconstruction:

WHEREAS, the Commission's form of proposal for the renovation or replacement, construction of the Portage and Brady's Leap Service Plazas were divided into five base bid packages identified as Bid Package #1 (Sitework Contract); Bid Package #2 (General Trades Contract); Bid Package #3 (HVAC Contract); Bid Package #4 (Plumbing Contract) and Bid Package #5 (Electrical Contract) and also gave prospective bidders the option to submit alternative bid combinations for bid packages identified as: Combined Bid -A (includes Bid Packages #2, #3, #4 and #5) Combined Bid -B (Includes Bid Packages #1, #2, #3, #4 and #5) and Combined Bid -C (Includes Bid Packages #3 and #4);

WHEREAS, bids for the above-mentioned bid packages for the performance of said contracts were received on February 11, 2000;

WHEREAS, approximately twenty-six bidders submitted bids for the performance of the five base-bid packages with some bidders bidding on one or more packages;

WHEREAS, said bids have been reviewed and analyzed by the Commission's construction manager and members of the Commission's staff, and they have submitted a recommendation concerning such analyses and their recommendation is before the Commission, and the Commission's executive director has made his recommendation to the Commission predicated upon such analyses;

WHEREAS, all bids for said contracts were solicited on the basis of the terms and conditions and specifications stated in the bid invitation and bid documents in connection with Contract No. 53-99-01 and Contract 53-99-02 and the following bidders have been determined by the Commission to be the lowest responsive and responsible bid received:
