## Resolution Awarding Contract No. 58-02-03

WHEREAS, the Commission has duly advertised according to law for bids upon a contract for demolition and reconstruction of toll plaza utility building, toll booths and canopy to the Commission's Interchange 152 ("North Olmsted/Cleveland") located at Milepost 152.2 in Lorain County herein designated Contract No. 58-02-02 and to the Commission's Interchange 118 ("Sandusky/Norwalk") located at Milepost 118.5 in Erie County herein designated Contract No. 58-02-03;

WHEREAS, the Commission has received bids from three bidders for the performance of said contracts, and bidders were given the option to submit a single bid or a combination thereof in response to Contract No. 58-02-02 and 58-02-03;

WHEREAS, said bids have been reviewed and analyzed by the Commission's deputy executive/chief engineer, and he has submitted a report concerning such analysis and his report is before the Commission and the Commission's executive director has made his recommendation to the Commission predicated upon such analysis;

WHEREAS, all bids for said contract were solicited on the basis of the same terms and conditions and the same specifications, and the bid of Mosser Construction, Inc. of Fremont, Ohio, in the amount of \$4,858,437.30 for the performance of Contract No. 58-02-03 has been determined by the Commission to be the lowest responsive and responsible bid received;

WHEREAS, the award of Contract No. 58-02-02 (Interchange 152, "North Olmsted/Cleveland") will be covered in a separate resolution;

WHEREAS, the Commission has been advised by its general counsel that said bid conforms to the requirements of Section 5537.07, Section 9.312 and Section 153.54, all of the Revised Code of Ohio, and that a performance bond with good and sufficient surety has been submitted by Mosser Construction, Inc.;

NOW, THEREFORE, BE IT

RESOLVED that the bid of **Mosser Construction, Inc.** of Fremont, Ohio, in the amount of **\$4,858,437.30** for the performance of **Contract No. 58-02-03** is, and is by the Commission, determined to be the lowest responsive and responsible bid received for the performance of said contract, and is accepted, and that the chairperson and executive director, or either of them, hereby is authorized (1) to execute a contract with said successful bidder in the form heretofore prescribed by the Commission pursuant to the aforesaid bid; (2) to direct the return to the other bidder of its bid security, when appropriate, and (3) to take any and all action necessary or proper to carry out the terms of said bid and of said contract; and

FURTHER RESOLVED that Project No. 58-02-03 is designated a System Project under the Commission's 1994 Master Trust Agreement.
