OHIO TURNPIKE COMMISSION

Resolution Ratifying Award of Contract for the Operation of the Food Concessions at Units 1, 2 and 5 at the Commission's Great Lakes and Towpath Service Plazas under Contract No. TR-8B

WHEREAS, on March 17, 2003 by Resolution No. 7-2003, the Commission formally approved the former general counsel's action to rescind the award of contract with Advanced Restaurant Concepts, Inc. ("ARCI") of Toledo, Ohio for the operation of the food concessions of Units 1, 2 and 5 at the Commission's Great Lakes and Towpath Service Plazas under Contract TR-8B, which award was confirmed by Resolution No. 21-1999;

WHEREAS, shortly after the Commission rescinded the award of contract with ARCI, representatives from HMS Host, Inc. of Bethesda, Maryland met with Commission staff members and presented a proposal for the operation of the food concessions of Units 1, 2 and 5 at the Commission's Great Lakes and Towpath Service Plazas;

WHEREAS, the current executive director and other members of the Commission's staff are satisfied with the capacity and ability of HMS Host to perform its obligations pursuant to its proposal;

WHEREAS, members of the Commission's staff reviewed the proposal and subsequent meetings were held to clarify its proposal and to negotiate the terms of said contract;

WHEREAS, HMS Host proposes the following food concepts for Units 1, 2 and 5:

WHEREAS, the terms were finalized and contract documents were forwarded to representatives of HMS Host on February 21, 2002, which contract reflects an initial seven (7) year term, and at the Commission's option, to extend for up to five (5) successive five (5) year terms;

NOW, THEREFORE, BE IT

RESOLVED that the Commission hereby ratifies the actions taken by the former executive director relating to the award, negotiation and execution of the contracts with HMS Host for the operation of Units 1, 2 and 5, at the Commission's Great Lakes and Towpath Service Plazas.
