

OHIO TURNPIKE COMMISSION

Resolution Awarding Contract No. 46-03-01

WHEREAS, the Commission has duly advertised according to law for bids upon a contract for furnishing and applying retro-reflective pavement markings on the Ohio Turnpike mainline roadway, herein designated **Contract No. 46-03-01** which has been divided into **Group I** which consists of all markings placed between Milepost 0.0 to Milepost 126.0 in Williams, Fulton, Lucas, Wood, Ottawa, Sandusky and Erie Counties and **Group II** which consists of all markings placed between Milepost 126.0 to Milepost 241.3 in Erie, Lorain, Cuyahoga, Summit, Portage, Trumbull and Mahoning Counties, Ohio;

WHEREAS, the Commission has received bids from two bidders for the performance of said contract, and bidders were given the option to submit a single bid in response to Group I or Group II or any combination thereof under Contract No. 46-03-01;

WHEREAS, said bids have been reviewed and analyzed by the Commission's chief engineer, and he has submitted a report concerning such analysis and his report is before the Commission and the Commission's executive director has made his recommendation to the Commission predicated upon such analysis;

WHEREAS, all bids for said contract were solicited on the basis of the same terms and conditions and the same specifications, and the combination bid of Oglesby Construction, Inc. of Norwalk, Ohio, in the amount of \$445,442.10 for the performance of Contract No. 46-03-01 has been determined by the Commission to be the lowest responsive and responsible bid received;

WHEREAS, the Commission has been advised by its general counsel that said bids conform to the requirements of Section 5537.07, Section 9.312 and Section 153.54, all of the Revised Code of Ohio, and that a performance bond with good and sufficient surety has been submitted by Oglesby Construction, Inc.

NOW, THEREFORE, BE IT

RESOLVED that the combination bid of **Oglesby Construction, Inc.** of Norwalk, Ohio, in the amount of **\$445,442.10** for the performance of **Contract No. 46-03-01** is, and is by the Commission, determined to be the lowest responsive and responsible bid received for the performance of said contract, and is accepted, and that the chairperson and executive director, or either of them, hereby is authorized (1) to execute a contract with said successful bidder in the form heretofore prescribed by the Commission pursuant to the aforesaid bids; (2) to direct the return to the other bidder of its bid security, when appropriate, and (3) to take any and all action necessary or proper to carry out the terms of said bid and of said contract; and

FURTHER RESOLVED that the Commission hereby authorizes and directs the executive director and the chief engineer to assign Quality Control Inspection, Inc., Bedford, Ohio, to Contract No. 46-03-01 for the of performing construction inspection. Such assignment shall be in accordance with the 2003-2004 Engineering Services Agreement between the Ohio Turnpike Commission and Quality Control Inspection, Inc.; and

FURTHER RESOLVED that Project No. 46-03-01 is designated a System Project under the Commission's 1994 Master Trust Agreement.
