

**Maintenance Worker – Vehicle Equipment Services/Roadway (Body Shop)**

The Ohio Turnpike Commission is seeking a Maintenance Worker – Vehicle Equipment Services/Roadway (Body Shop) employee to work in our Maintenance Department – Division II Hiram location. Qualified candidates must possess of minimum of two (2) years experience or training in vehicle painting and refinishing, structural/non-structural repair, damage repair, and mechanical repair. Exhibit satisfactory skill to provide for high quality workmanship of vehicle painting and refinishing. Required to reside within approximately a twenty-five (25) mile radius of the division installation. Must possess a valid Class “D” Driver License; a minimum of a valid Class “B” Commercial Driver License (CDL) within one (1) month of the permanent assignment or date of hire; and a valid Class “A” Commercial Driver License (CDL) with a tanker endorsement within six (6) months of the date of hire during the probationary period.

Knowledge and skill of vehicle and equipment maintenance and finish practices and procedures; safety practices and procedures\*. Skilled in the operation and use of a variety of tools and equipment including hand tools, power tools, saws, sanders, torches, etc. Perform snow and ice control operations and traffic control\*. Understand electrical and mechanical systems, read and understand schematics, plans and specifications; work alone on most tasks; stand, walk or bend continuously; lift and carry 40 pounds frequently and 80 pounds occasionally; use mechanical equipment; radio and telephone communications\*; use limbs/fingers easily to perform manual tasks. Assigned to an approximate 120 mile section of roadway with the ability to drive throughout the distance of the Ohio Turnpike.

Primary duties include the daily operation of servicing various vehicles and equipment; performs labor in connection with the repair and maintenance of vehicles and equipment including vehicle finish and painting, bodywork, minor mechanical and electrical, vehicle and equipment preparation, etc.; provide any support that may be necessary at the Division.

Secondary duties include the repair and maintenance of turnpike facilities, asphalt and concrete repair\*, drainage\*, mowing\*, guardrail and fences\*, roadway and bridges\*, paint buildings, facilities and equipment; respond to emergencies, accident scenes\*; erect traffic control and serve as a flagman; operation of medium and heavy duty trucks and equipment. Perform snow and ice removal operations when required and any other duties as may be assigned by the Chief Mechanic.

**SALARY**

The starting rate for this position is \$19.50 per hour plus excellent benefits.

**HOURS OF WORK/UNUSUAL WORK CONDITIONS**

Must be able to work for extended periods of time, particularly during snow and ice season. Required to be available to work overtime during on-call hours and work overtime in emergency and other situations, considerable overtime may be necessary.

May be exposed to extreme temperatures and changing weather conditions (rain, lightning, humidity, heat, cold, snow, ice); will work indoors and outdoors; climb ladder or scaffolding; work in confined areas; exposure to sawdust, fumes, dust, dirt, grease, human blood and body fluids, animal carcasses, unpleasant odors, vibration and loud noise; high voltage and dangerous power tools, work from extension ladder, scaffolding, elevated platforms and bridges; hazardous materials and surface spills.
